Subject: Grant in aid of 1st installment under the Centrally Sponsored Scheme of Pradhan Mantri Jan Vikas Karyakram(PMJVK) to Government of Mizoram.

Sir,

I am directed to convey sanction of the President for release of an amount of **Rs. 55,29,54,000/- (Rupees Fifty-Five Crore Twenty-Nine Lakh Fifty-Four Thousand Only)** as 1st installment of Central Share to the Government of Mizoram for implementing the scheme "Pradhan Mantri Jan Vikas Karyakram" for Minority Concentration Areas in the State of Mizoram for the year 2021-22 as per the details enclosed at **Annexure -I**. The non-recurring grant may be released to the Govt. of Mizoram through CAS, Reserve Bank of India, Nagpur.

2. The State Government should ensure that proportionate share of 50% of State share for the project mentioned at Annexure-I is released to the implementing agency along with Central share. The approval is subject to condition laid down by EC as detailed in the minutes of the meeting, conveyed to concerned vide OM No MSDP-13/51/2020-MSDP-MOMA dated 28.09.2020.

3. The expenditure is debitable to Demand No.69, Ministry of Minority Affairs Major Head- "3601" Grant-in-aid to State Government, 06- Grants for State Plan Schemes (Sub Major Head), 101 -General-(Welfare of Schedule Casts/Schedule Tribes, Other Backward Classes and Minorities) -other grants (Minor Head), 64-Pradhan Mantri Jan Vikas Karyakram for minorities, 64.00.35 Grant for creation of capital assets the year 2021-22


4 Since it is a fresh release for the plan of PMJVK, no UC is pending. Utilization Certificate for this grant should be submitted by the State in the prescribed format within 12 months of the closure of financial year. As per the conditions contained in para 12.5 of the guideline of PMJVK, (i) Quarterly Progress Report, (ii) Utilization Certificate, (iii) Report regarding release of the State share and (iv) Photographs of the Assets so far created, should also be furnished.

5. The sanction is issued on the commitment given by the State Govt. that villages/locations having a substantial minority population will be/has been selected for the projects mentioned at Annexure-I and that duplication will not take place.

7. This is to certify that the present sanction/ expenditure is covered under MEP for the month of June, 2021 and Integrated Finance Division (IFD) has approved the expenditure during the 1st quarter of the financial year 2021-22.
8. Funds should be released by the State Govt. to the implementing agencies immediately upon receipt of the same from Govt. of India and as per the directions of Govt. of India, Ministry of Finance; parking of funds at any level is strictly prohibited.
9. Utilization of the above-mentioned amount by the State Government is subject to the terms and conditioned at **Annexure-II**.
10. The amount of Rs. 5529.54 lakhs has been re-appropriated from Major Head 2552.00.450.24.00.35 to Major Head MH-3601.06.101.64.00.35 vide re-appropriation Order no 6/2021-22 dated 04.06.2021 of Budget Division, Ministry of Minority Affairs.
11. This sanction issues with concurrence of IFD Note No. 49 dated 04.06.2021 of File no. 13/59/2020 .2020. It is noted at S. No. 11 in the Grant-in-aid Register.

- viii. Grantee will ensure that there is no duplication of work.
- ix. Grantee shall ensure that priority be given to villages/locations with substantial percentage of minority population.
